1. A Proposal has been filed by applicant school to determine fees for the year 2021-2022, 2022-2023 and 2023-2024.
2. Applicant School is affiliated with CBSE Board.
3. School is English Medium School.
4. School is situated at. Opp. Nilkantheshwar Mahadev, Zadeshwar, Bharuch-392011.
5. This Proposal is for Std.1 to H.S. (Gen.) (Sci.).
6. School has filed this proposal on 30/12/2019 to determine fees for the year 2021-22, 2022-23 and 2023-24. This Committee has gone through the papers submitted by the school and passed order of provisional fees for the year 2021-22, 2022-23 and 2023-24.
7. Being aggrieved by the said order school has filed its objection vide letter dated 27-12-2021. This committee has issued a letter dated 31-12-2021 for personal hearing and sought certain information along with certain documents. On 31/01/2022 Mr Khandubhai M. Patel, Trustee of the school, Mrs Krupal H. Shah, Accountant of the school and Mr Mukesh H. Patel, Accountant of the school appeared before the committee and hearing was conducted.

8. During hearing the authorized persons of the school insist to allow 7% increase in fees for the year 2021-22 over the final fees determined by the FRC for the year 2019-20 and further 5% increase in fees 2022-23 and 2023-24 respectively. Moreover, they also requested to allow increment of 42\$ in 2021-22, 44\$ in 2022-23 and 46\$ in 2023-24 in the fees of NRI Students. After evaluating the documents submitted by the school, it appears that the increment asked by the school is just nearer to the fees prescribed in statute and also considering the inflation rate, hike in Salary and increments of employee of the school, this committee think it fit to allow 7% increase in fees for the year 2021-22 and further 5% increase in fees 2022-23 and 2023-24 respectively as well as the increment of Dollar for NRI Students and determine as under:
